The attention of the District Educational Officers / Deputy Educational Officers / Deputy Inspector of Schools / Mandal Educational Officers in the Zone-II is invited to the references cited and they are informed that the monitoring, reviews and evaluation are the integral components and key factors in planning & administration and the visits and Inspections of field functionaries will lay tremendous impact on the functionality of the schools which in turn helps in elevating the educational standards.

But it is observed that many field functionaries are not submitting the Tentative Tour Programs, Tour Diaries, Visits and Inspection Reports to the authorities and there is lack of reviews and monitoring on visits and Inspections at Mandal level, Divisional level and also in District level which leads to performance lagging in the field functionaries and resulting damage to the aims of the Government in imparting quality education.

Hence, it is necessary to observe and follow the instructions and monthly targets which were issued previously by the Commissioner of School Education, A.P., in the references cited, in respect of Visits and Inspections, which are as follows:
